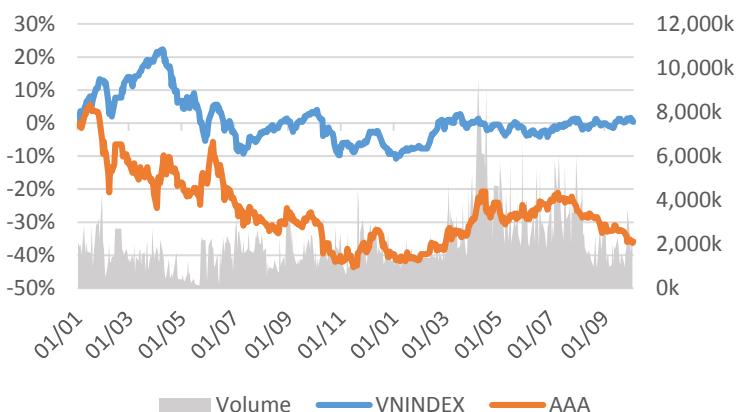

AAA - 短期風險趨於降低

- AAA 的股票評級為 59 分，尤其是 AAA 的基本得分為 87 分，P/E TTM 為 5.9 倍，表明當前的價格水平僅適合投資者買進。
- AAA 的價格圖表跌至約 14.5 的短期支撐區，並且短期風險已顯示出稍弱的跡象，這表明我們評估價格圖表可能在未來的幾個交易日中恢復。因此，在短期內，我們建議從“賣出”變成“追蹤”。
