

GVR - 建立短期反轉模式

- GVR 的股票評級為 84 點,因此我們維持該股票的積極增長評級。GVR 的價格圖表收盤上漲 2.4%,成交量高於 20 天平均水平。 與此同時,GVR 的價格圖表顯示出進入積極的強烈波動期的跡象。此外,GVR的價格走勢圖也建立了倒掛的 H&S 反轉格局,顯示短期風險顯著降低。
- GVR的短期走勢轉為上漲。因此,我們建議短線投資者可 考慮現價買進股票,比重低於 5%;當價格強度在 80 點以 上時,逐漸增加至最優權重 31.89%。


TCM - 短期風險驟降

- TCM 的股票評級為 81 點,因此我們將該股票的增長評級轉為積極。
- TCM價格走勢圖收漲 6%,突破 20 日均線,成交量 驟增。同時,價格走勢圖進入積極的強烈波動期, 短期風險明顯下降。此外,價格走勢圖也形成了短 線反轉格局,TCM短線走勢也轉為上漲。
- 我們建議投資者可考慮現價買進股票,比重低於 5%,並逐步提升至 31.6%。
