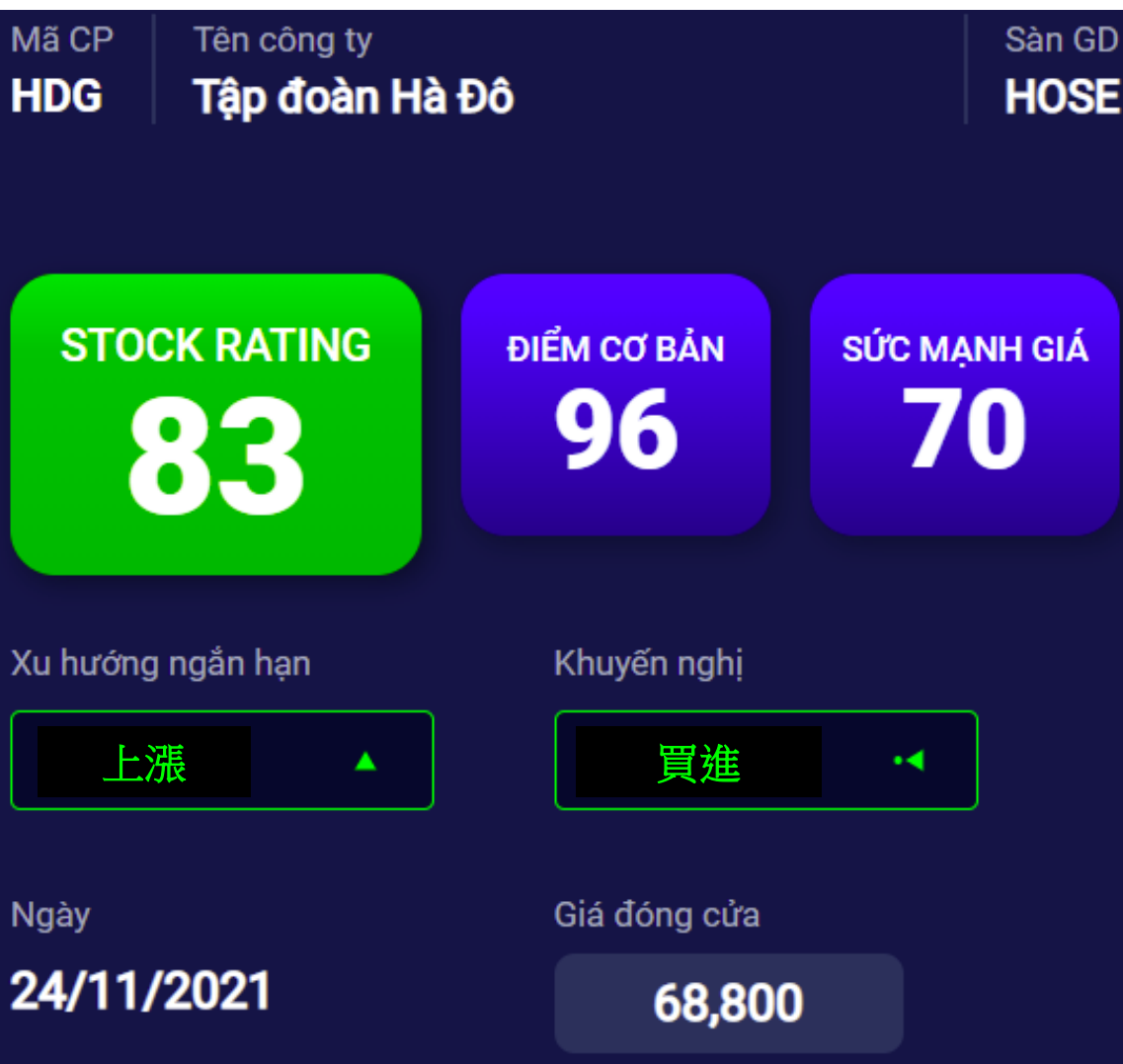

HDG – 價格圖表創下 52 周高點

- HDG 的股票評級為 83 點，因此我們維持對該股票的積極增長評級。不過，價格強度仍低於 80 點，因此投資者應持有較低的比例。HDG 的價格圖表收盤上漲 7% 並創下 52 周高點，成交量飆升至 20 天平均水平以上。
- 同時，價格圖表顯示出進入積極的強烈波動期的跡象，表明價格圖表可能會移動至更高的水平。此外，短期風險大幅下跌。
- 我們建議短線投資者可考慮現價買進股票，比重應低於 5%；若價格強度在 80 點以上，則逐步增加持股比重至 43.47%。

SHB - 價格圖表仍處於調整階段

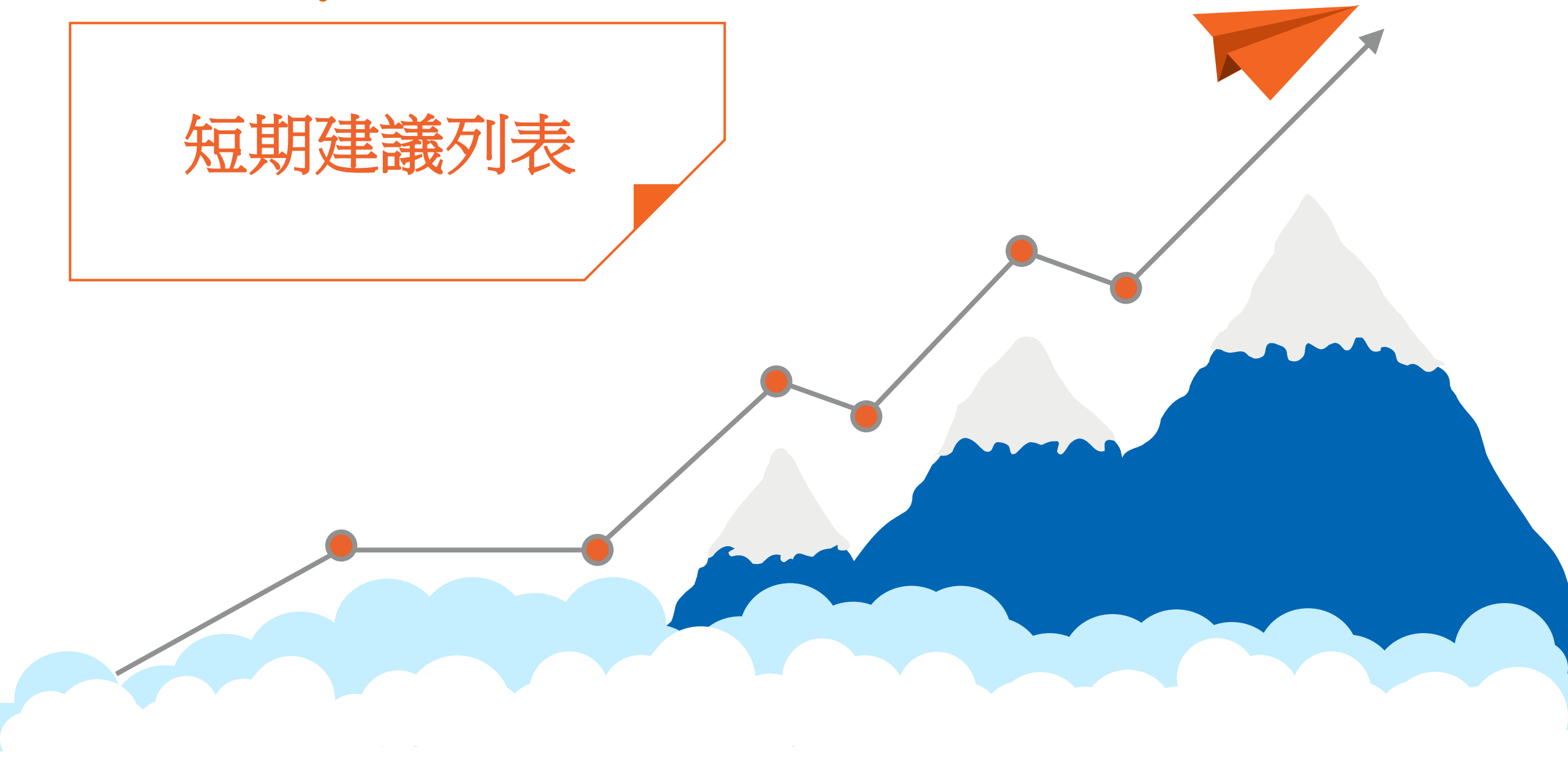
- SHB 的股票評級為 70 點，因此我們維持該股票的中性增長評級。SHB 價格走勢圖收漲 4.8%，成交量強勁突破 20 日均線。同時，完全突破 20 日均線，但價格走勢圖仍處於調整的階段，因此價格走勢圖在接下來的交易日可能仍有回調幅度。此外，SHB 的短期走勢也轉為上漲。
- 我們建議短線投資者可考慮買進 SHB，我們的系統短期預期為 31.09。同時，短線投資者應只考慮低於 5% 的比重投資；當股票評級在 80 點以上時，則逐漸增加持股比例。
