## VN30F1M 的評估

- VN30F2112 在 1537 點平衡並再次恢復。在 15 分鐘幀內，收窄趨勢已經形成，最近的阻力位在 1553-1555 點，而支撐位在 1547-1548 點。
- MACD 在 15 分鐘幀下發出買進的信號，但低於零，表明本週首日的複蘇是技術性，1553-1555 點區將為值得關注的阻力位。

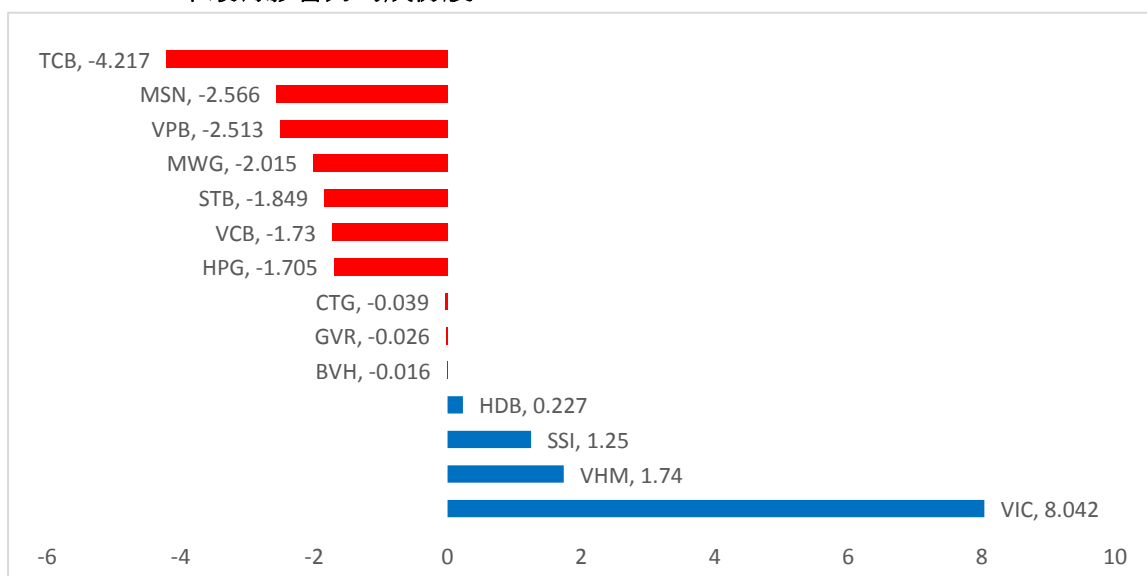

### VN30-INDEX 指數走勢

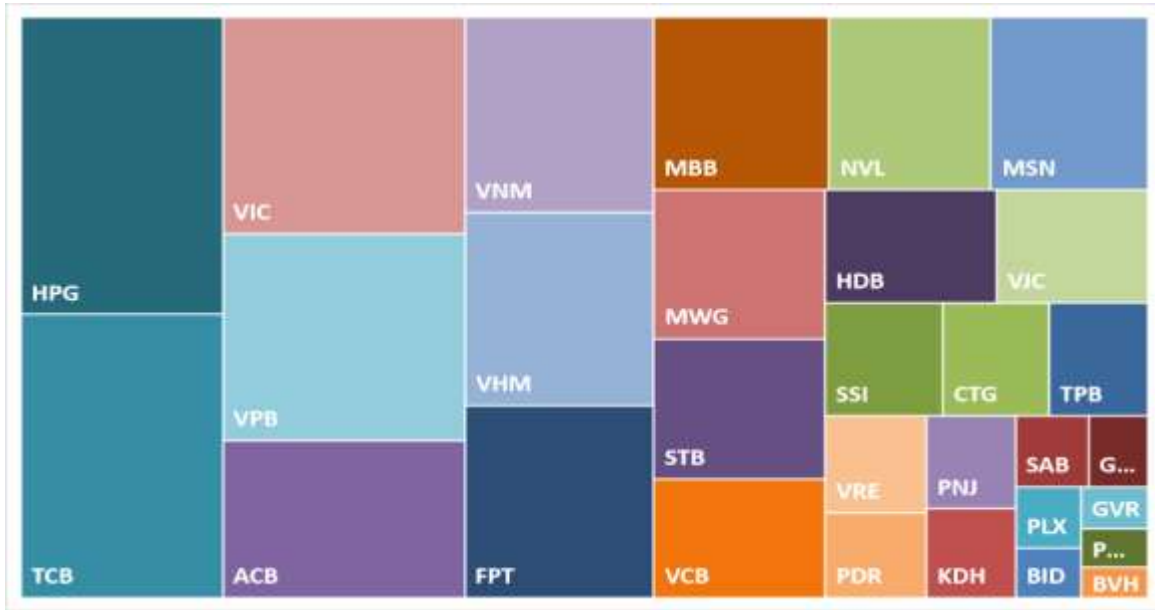
