### 銀行指數接近短期阻力

- 銀行股的行業評級為 60 點,因此我們維持該類股票的中性增長評級。不利點是當銀行股的價格強度仍然為 30 點,表明現金流正在減弱,因此投資者應該持有較低的比例。
- 銀行股價走勢圖收漲 3.4%。同時,銀行股價格圖表接近短期阻力位,價格圖表仍處於短期調整階段,成交量仍低於 20日 均線。如果價格圖表在下一交易日繼續上漲,則短期趨勢可能會確認上漲。因此,建議短期投資者可繼續觀察。
- 值得關注的股票: TPB、VIB、STB、TCB、HDB。

### SHB - 出現短期反轉形態


- SHB 的股票評級為 66 點,因此我們仍然維持該類股票的中性增長評級。
- SHB 的價格圖表收盤量低於 20 天平均水平,上漲 7%。同時,價格圖表仍維持 20.30 的短期支撐位 和 19.27 的強勁支撐位。不過,SHB 的短期趨勢 仍然是下跌。積極點是 SHB 的價格圖表顯示出牛勢蟹形態,表明短期風險已顯著降低。
- 我們建議投資者繼續觀察股票;當價格圖表超過21.76 水平時,則可以考慮以低權重買進新股票。
