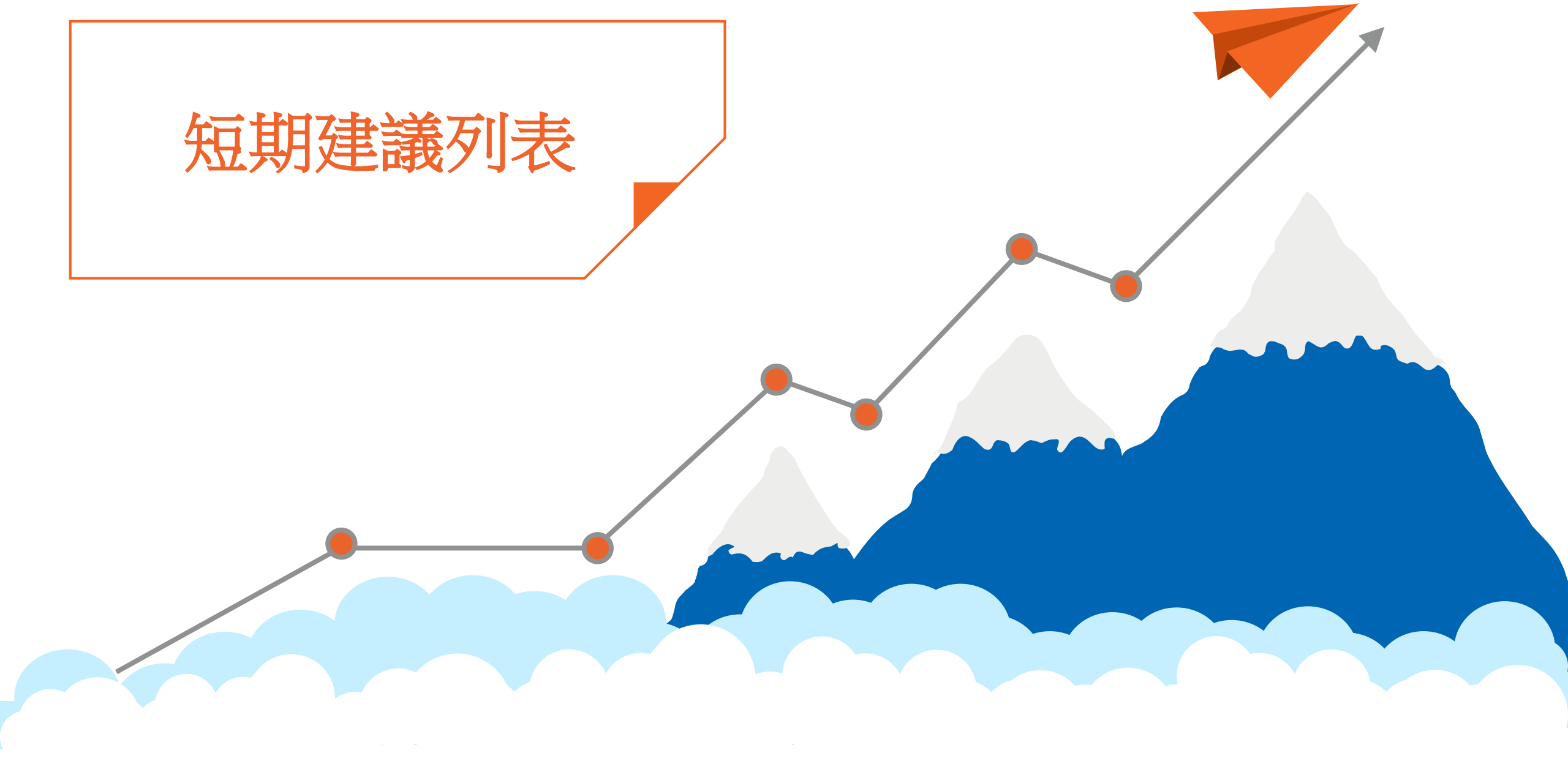
VND - 價格圖表未能突破 35.0 的阻力位

- VND 的股票評級為 97 點，因此我們維持該股票的積極增長評級。
- VND 價格圖表收盤上漲 0.3%，成交量仍高於 20 日均線。同時，價格圖表仍處於積極強烈波動的階段，因此短期風險仍然較低，但在市場短期風險處於上漲的背景下，價格圖表仍在 35.0 的阻力位附近交易，因此價格圖表難以完全突破 35.0 的阻力位。
- 我們建議在 2022 年 5 月 4 日買進 VND 股票，臨時回報率為 3.54%（詳見此處：<https://yuanta.com.vn/phan-tich/morning-note-05-04-2022-chi-so-vn-index-co-the-se-kiem-dinh-lai-vung-1517-1523-diem-vnd-ipa>）。因此，我們建議短期投資者可以繼續持有 VND 股票。
