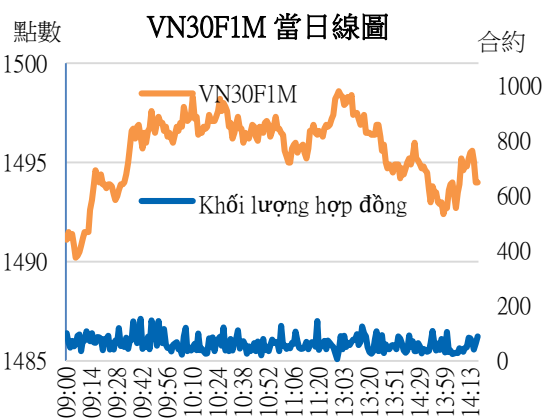
- 4 個期貨合約收漲 5-6 點。與 VN30-Index 相比，VN30F2204 的基差錄得超過負 12 點。

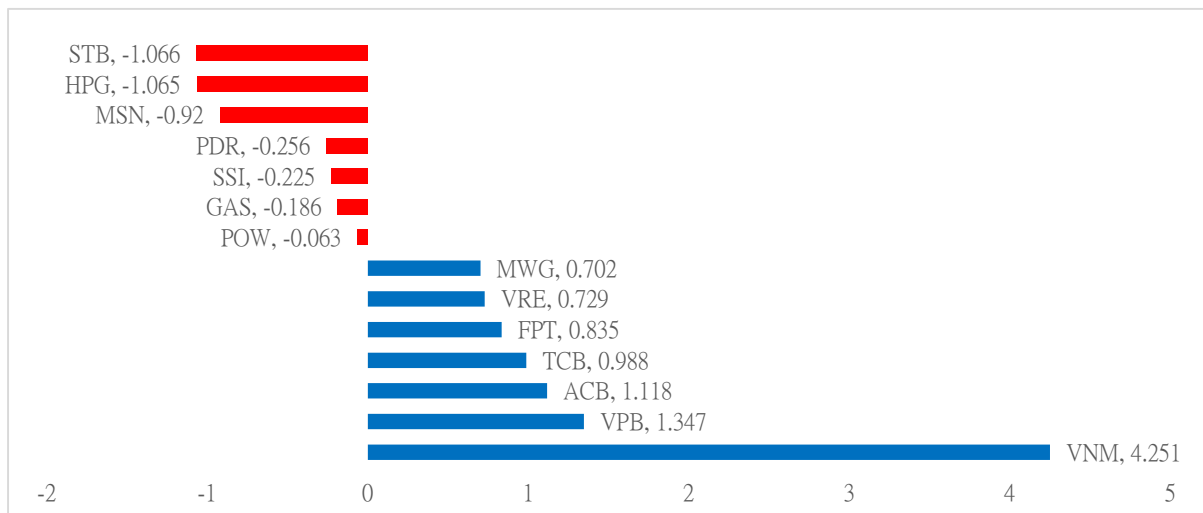
