



## FTS - 2022 年第一季度保持增長


- MBS 的股票評級為 94 點,因此我們維持該股票的積極 增長評級。
- 2022 年第一季度末,FTS 保持收入增長 54%,稅後利 潤增長 46%。同時,FTS 的 TTM ROE 達到 32% 仍高 於行業平均水平。
- FTS 的 TTM P/E 為 7.4 倍,低於行業平均水平 9.8 倍。
- FTS 價格走勢圖收漲 3%,成交量仍低於 20 日均線, 價格走勢圖在 45.0 支撐位附近交易。同時,價格走勢 圖顯示進入短期調整階段的跡象,如果價格走勢圖繼 續復甦,短期風險可能會下跌。不利點是現金流仍然 走弱,短期趨勢仍然是下跌。
- 我們建議短期投資者可以繼續觀察 FTS 股票。
