BCG - 價格走勢圖處於調整階段

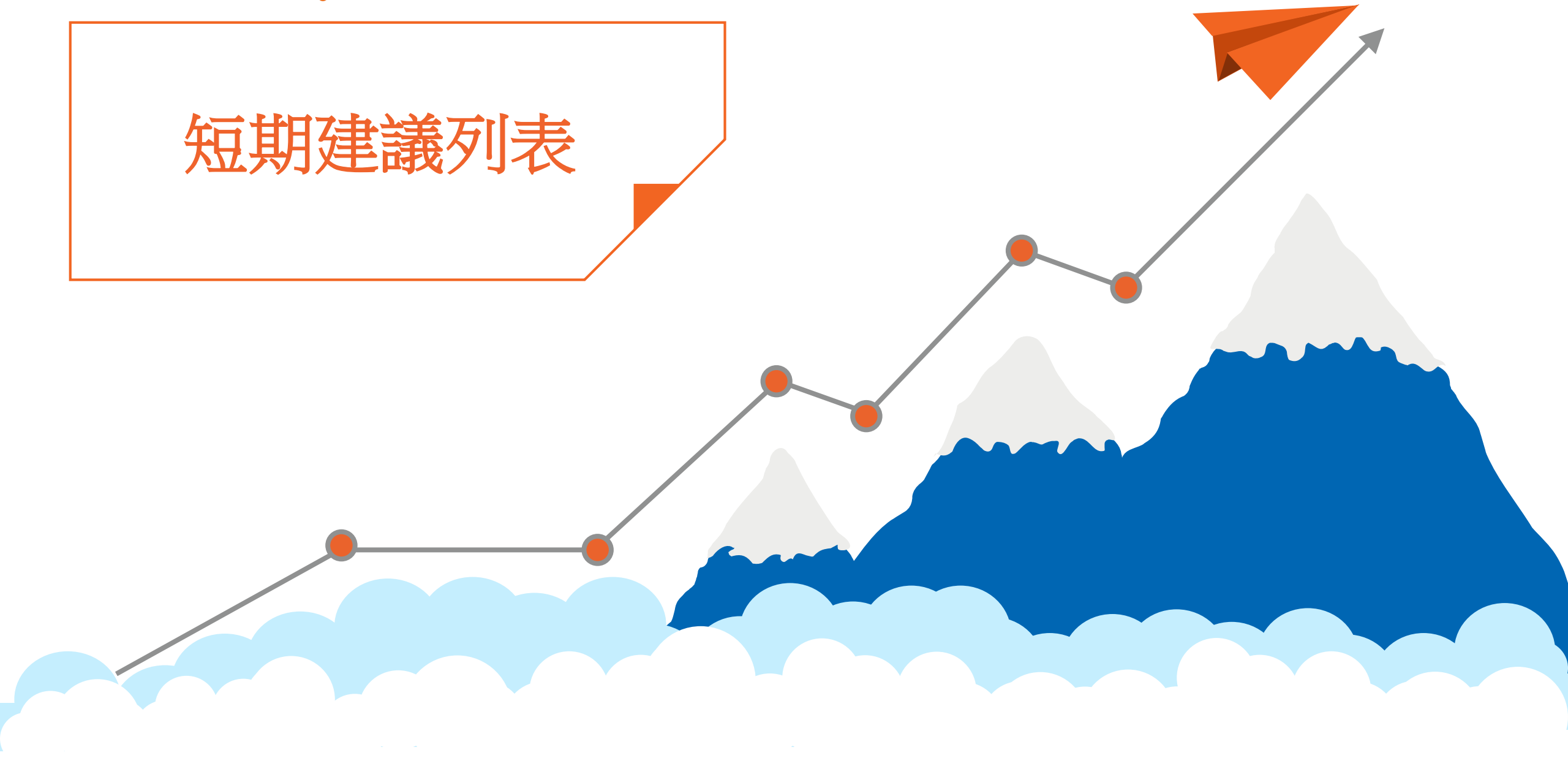
- BCG 的股票評級為 85 點，因此我們維持該股票的積極增長評級。
