

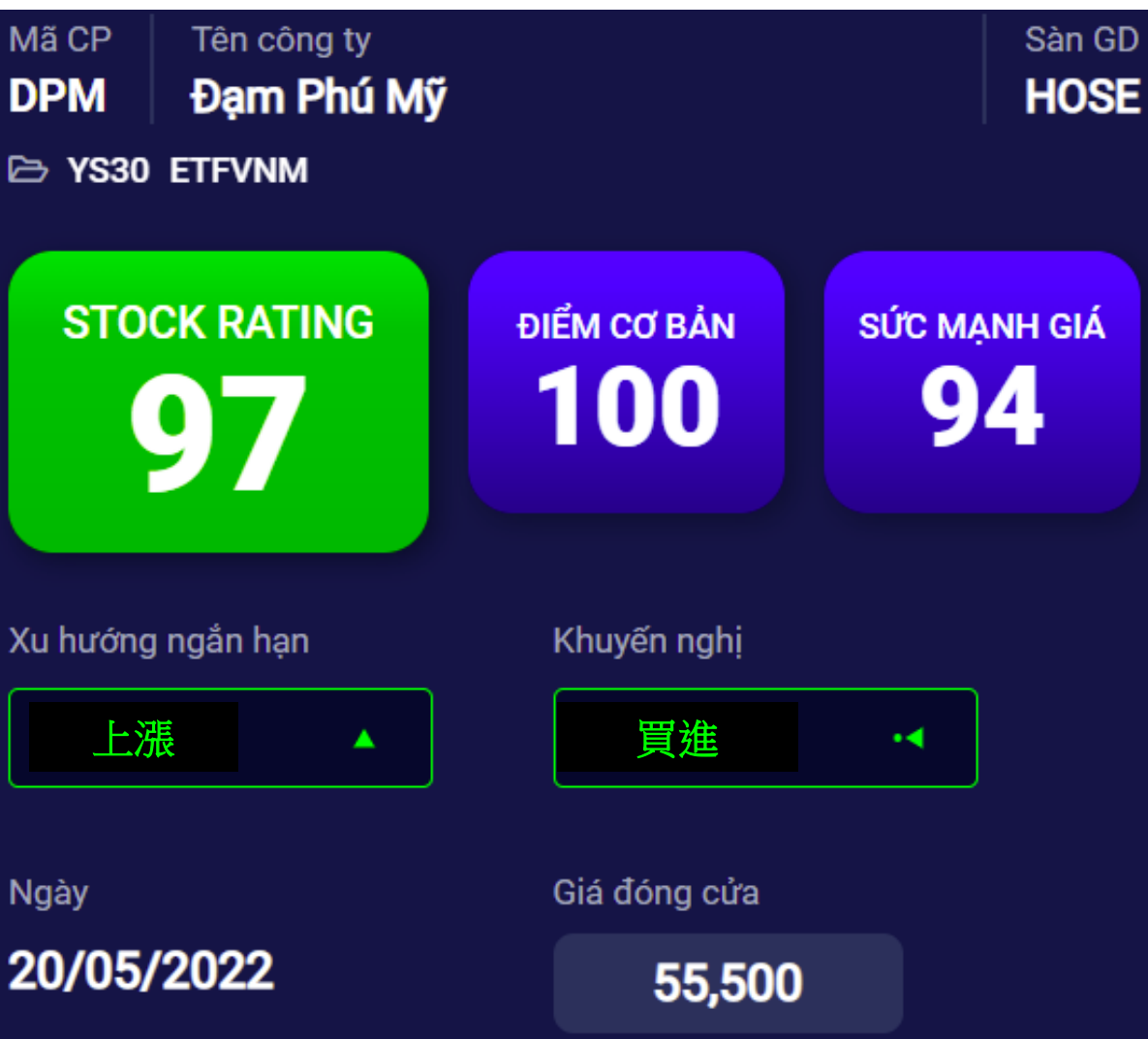

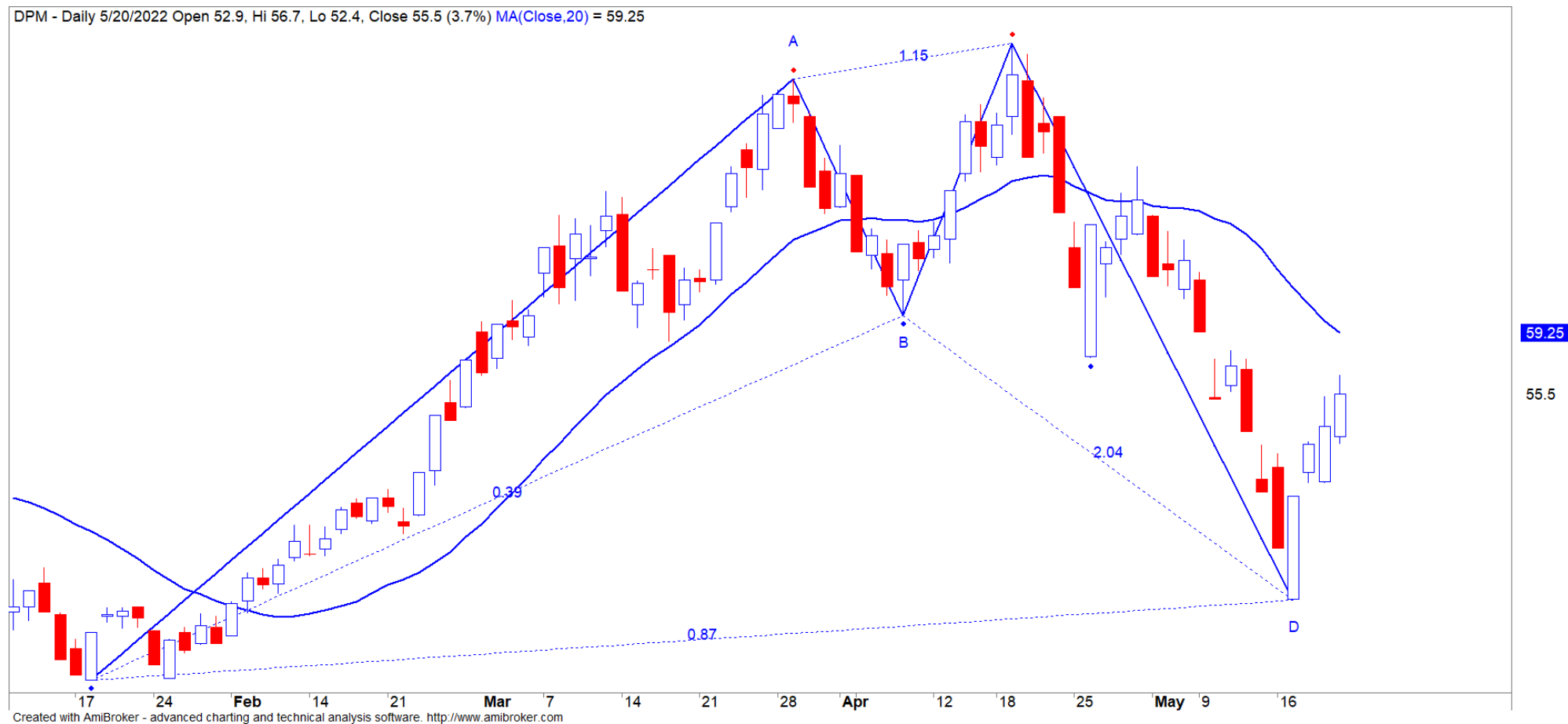

DPM - 形成上漲反轉模式

- DPM 的股票評級為 97 點，因此我們維持該股票的積極增長評級。
- DPM 的價格走勢圖收盤上漲 3.7%，成交量增加。同時，價格走勢圖有進入短期調整階段的跡象，價格走勢圖形成上漲蝙蝠短期反轉模式，顯示短期風險有逐漸下跌的跡象。
- DPM 的短期走勢也調整至上漲。因此，我們建議短期投資者可以考慮以 5% 的低比例以現價買進，如果市場的短期走勢得到我們的更為樂觀前景評估，將逐步增加比例至 11.28%。

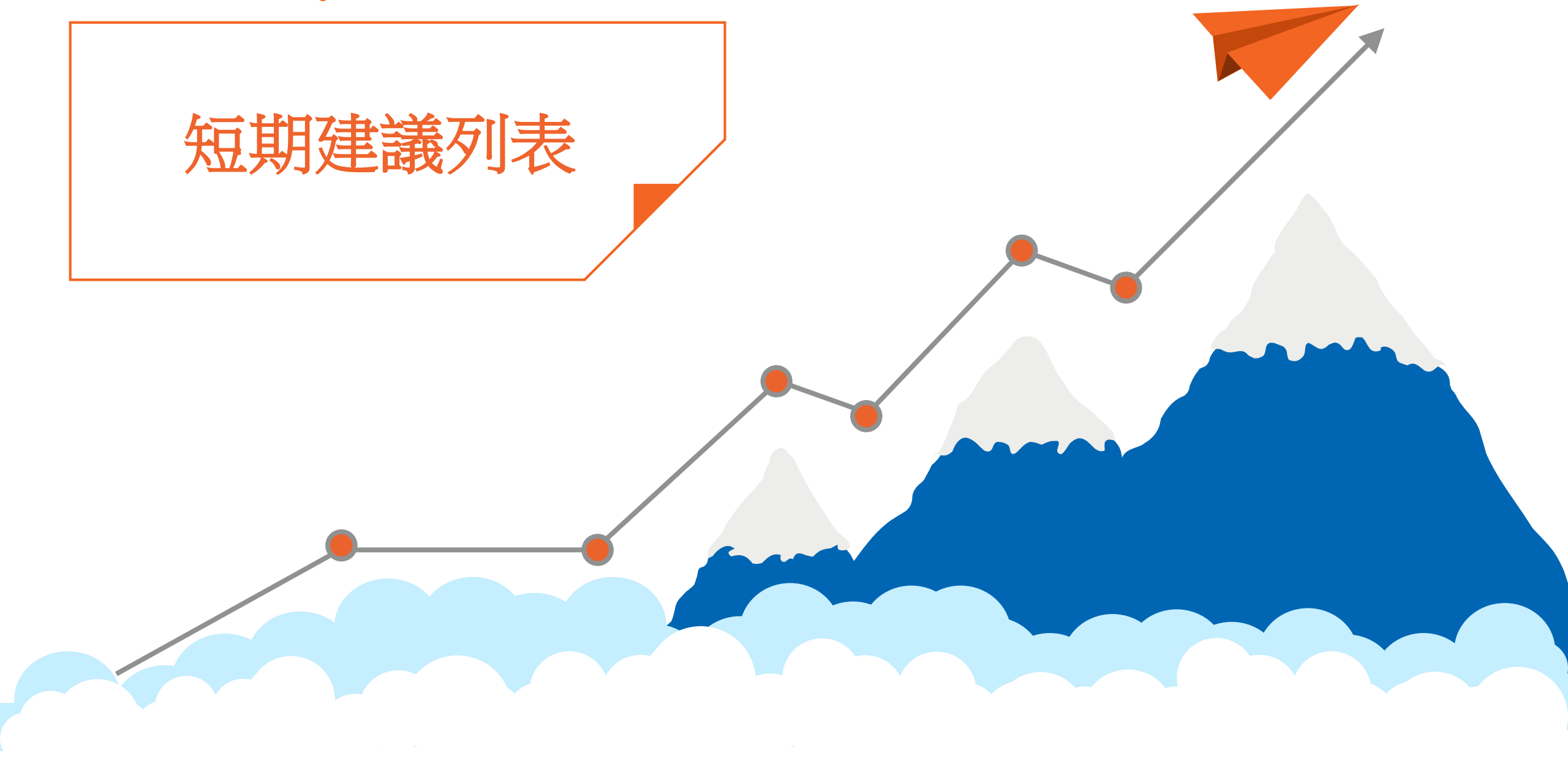
