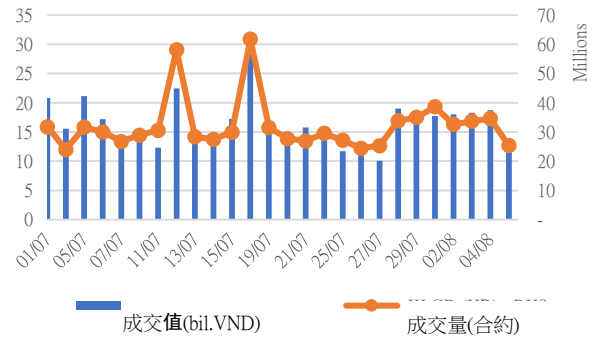


流動性下降

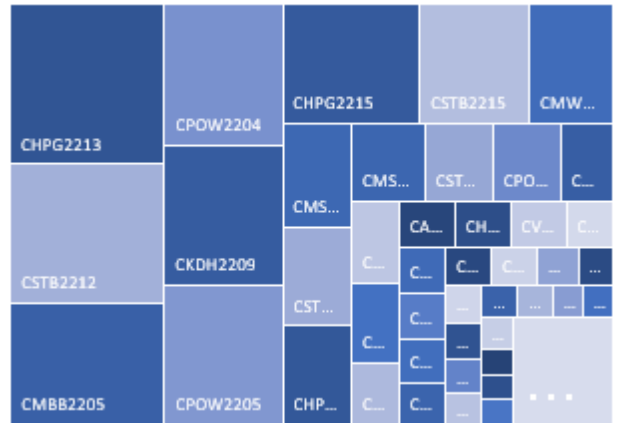
本週的最後個交易日繼續處於平靜的走勢，導致流動性下降，市場的大部分權證均下跌。HPG 和 STB 繼續成為市場上最活躍的權證，該板塊在當日也出現調整。我們認為在此時選擇認股權證以買進是相當困難，因為大部分上市認股權證的高價非常高。因此，我們建議投資者僅在估值合理的比例和較低的權證買進。

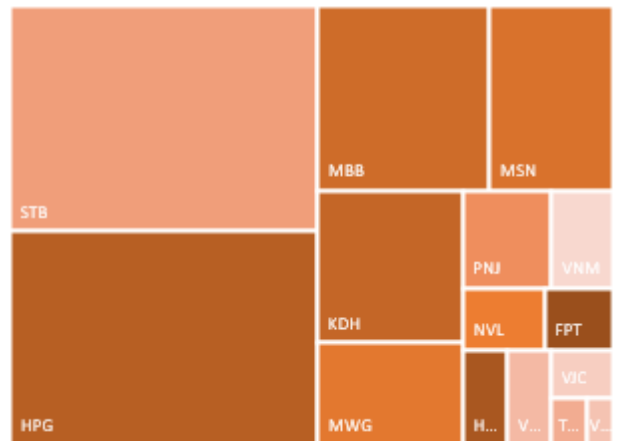
成交值和成交量

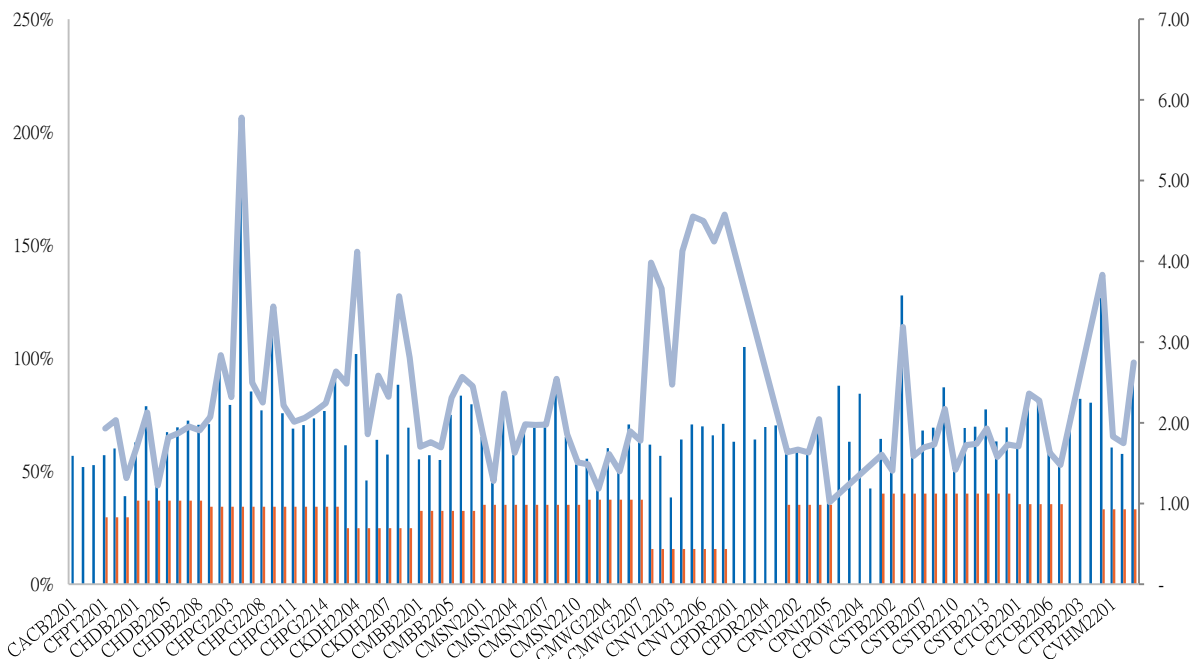
槓桿 (Effective gearing) 越高, 按標的證券的波動率就越大。

為了限制風險, 投資者應選擇具有現金狀態 (ITM), Premium 或隱含波動率偏低的認股權證。此外, 投資者也應優先對具有偏長 (兩週以上) 的剩餘交易盤數 (直至到期日) 的權證進行交易, 以限制風險。
