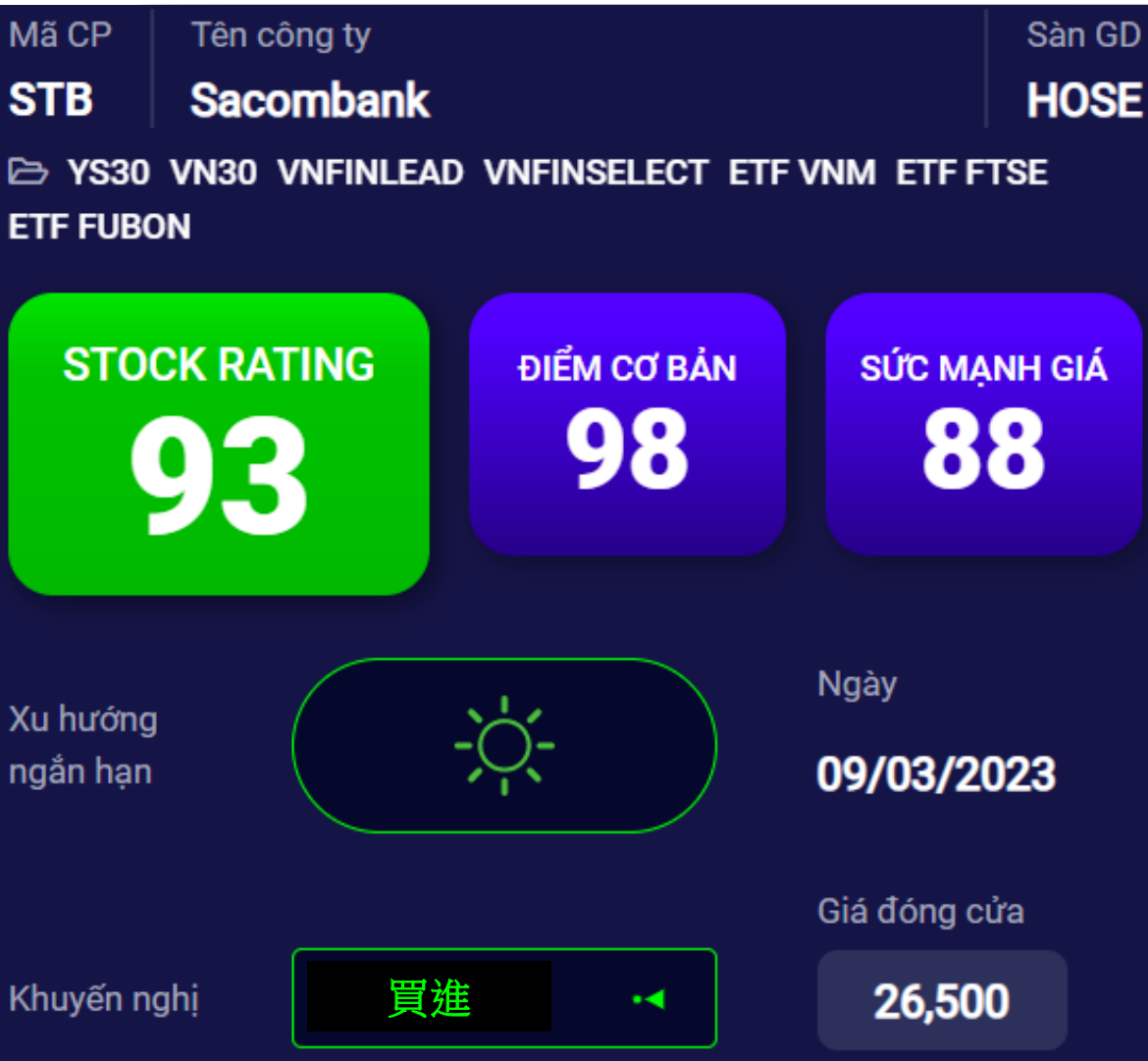

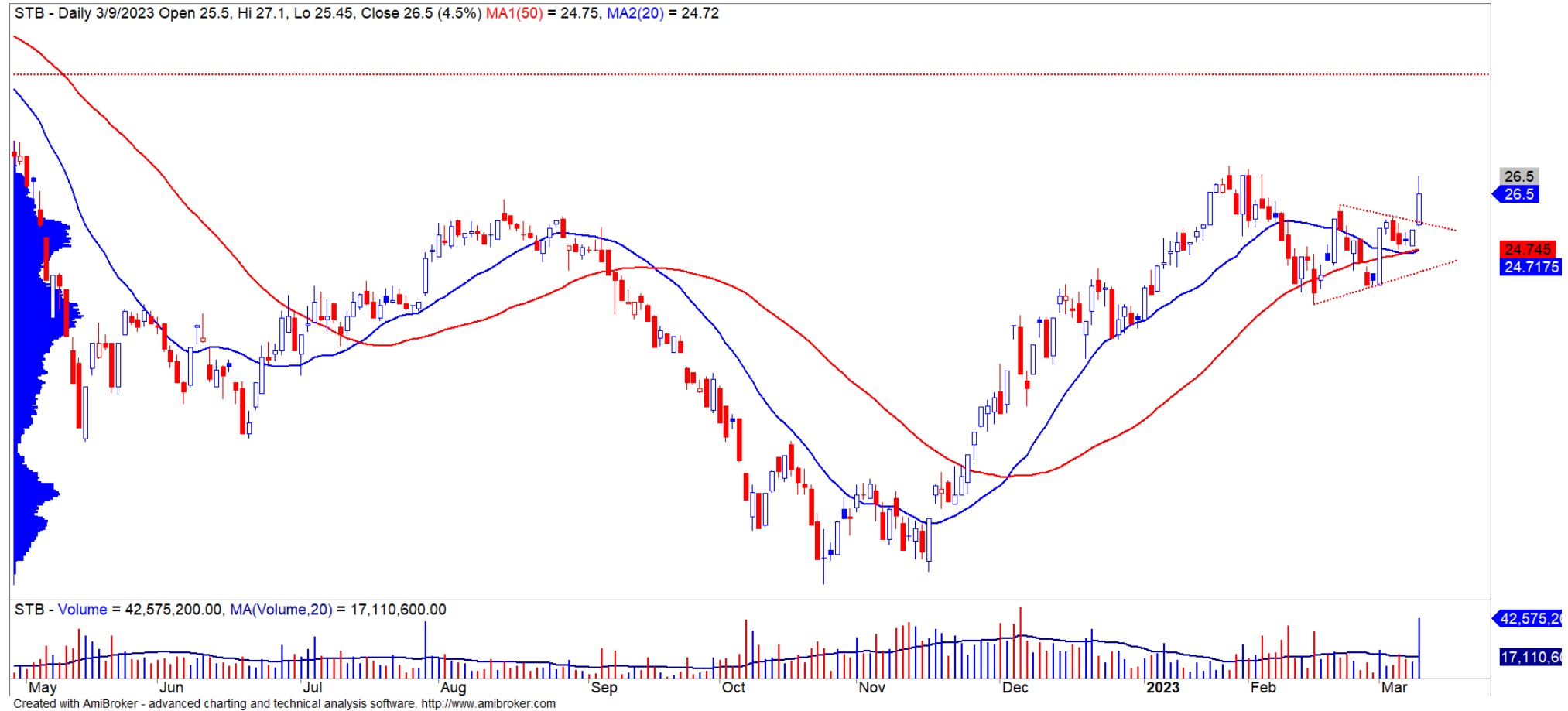

STB — 價格走勢圖可能會進入劇烈波動階段

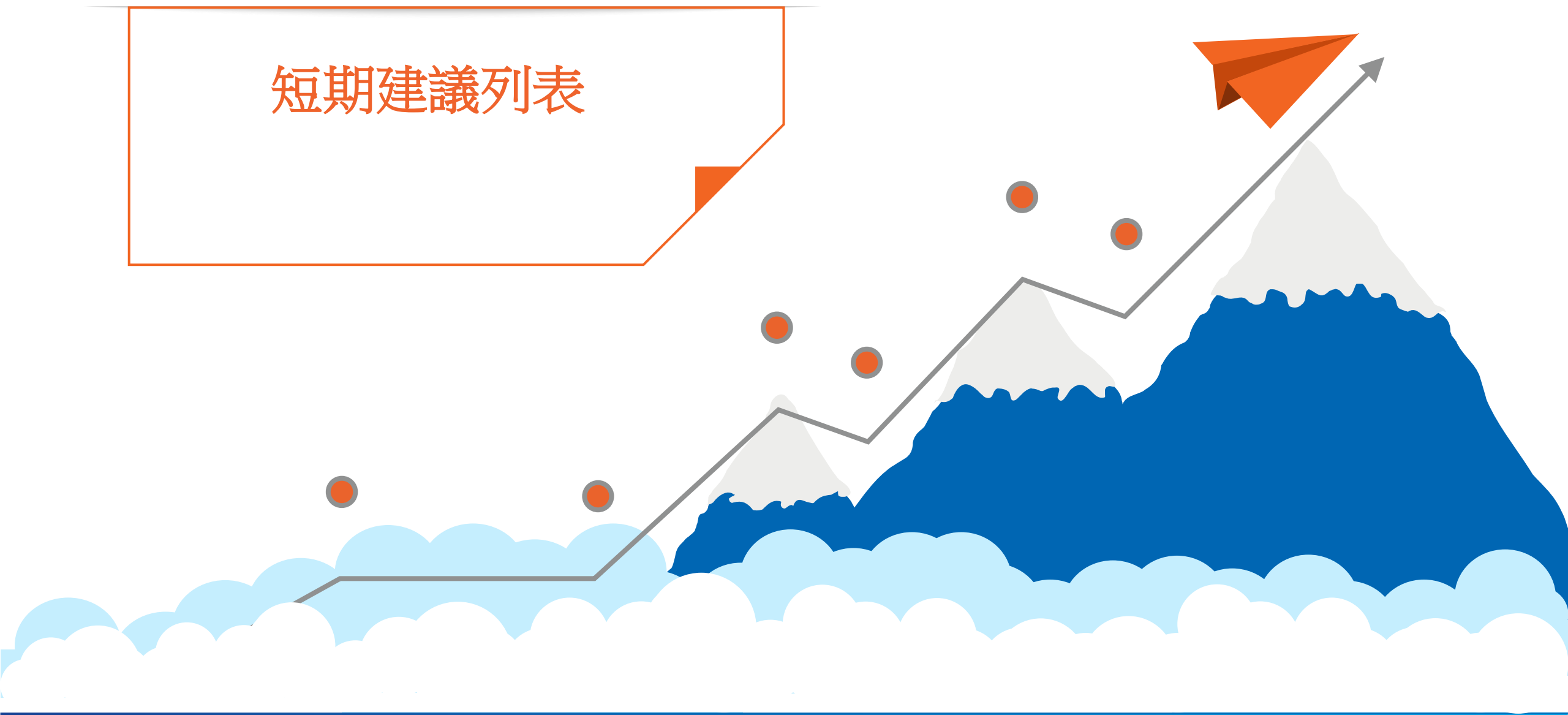
- STB 的股票評級為 93 點，因此我們維持該股票的積極增長評級。
- 與 20 日均線相比，STB 的價格走勢圖收盤上漲 4.5%，交易量突然增加。同時，價格走勢圖有進入積極劇烈波動期的跡象，因此價格走勢圖可能會快速突破 27.40 點的短期阻力位。
- STB 的價格走勢圖已退出三角形模式，顯示中期上漲趨勢可能會延續。
- STB 的短期趨勢也調整至上漲。因此，我們建議投資者可以考慮以 5% 的低比例買進，並等待市場的短期趨勢良好後逐步增加比例。
