運輸 — 確認短期上漲趨勢

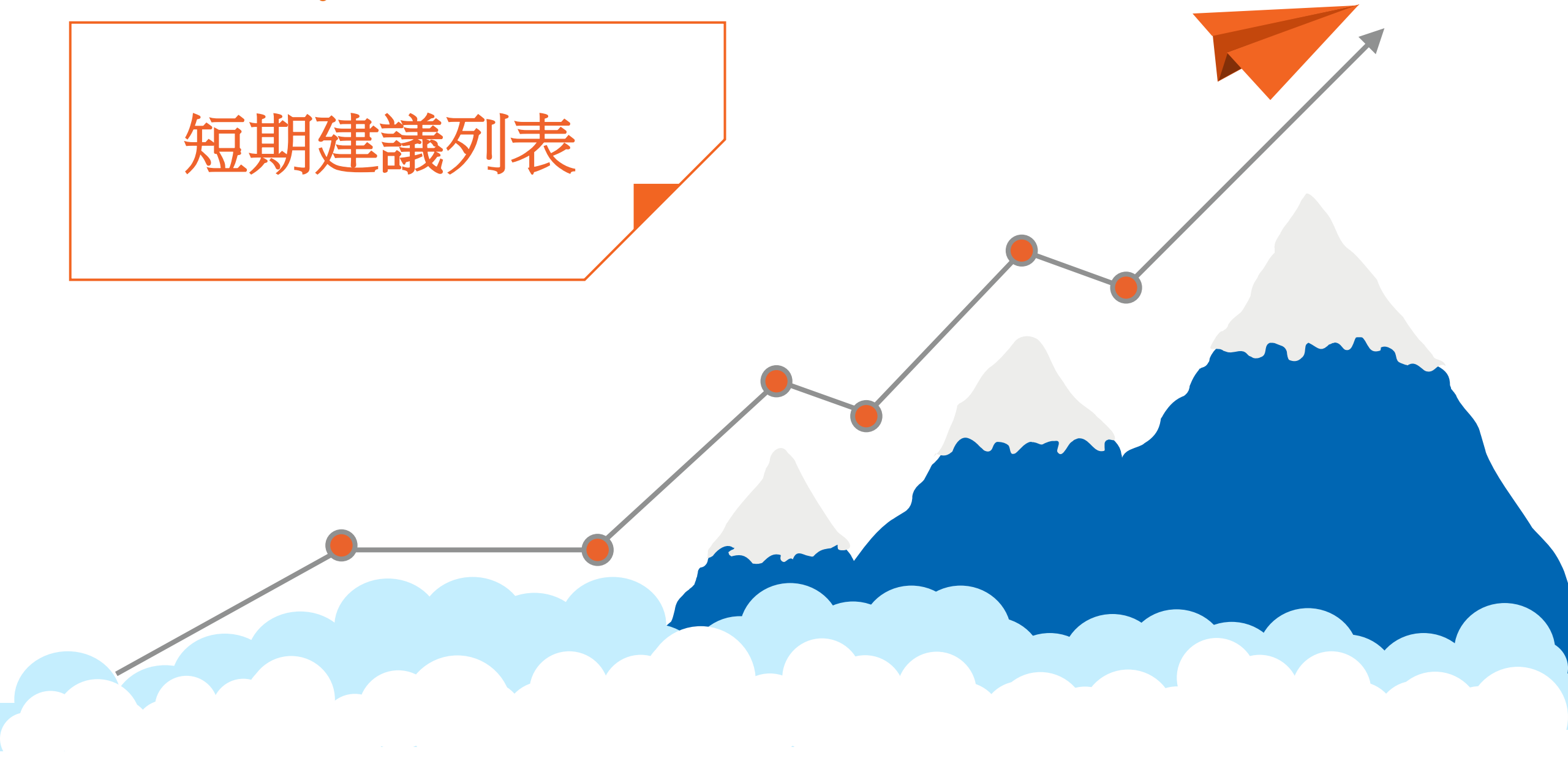
- 運輸的行業評級為 69 點，因此我們對運輸的增長評級為中性。
