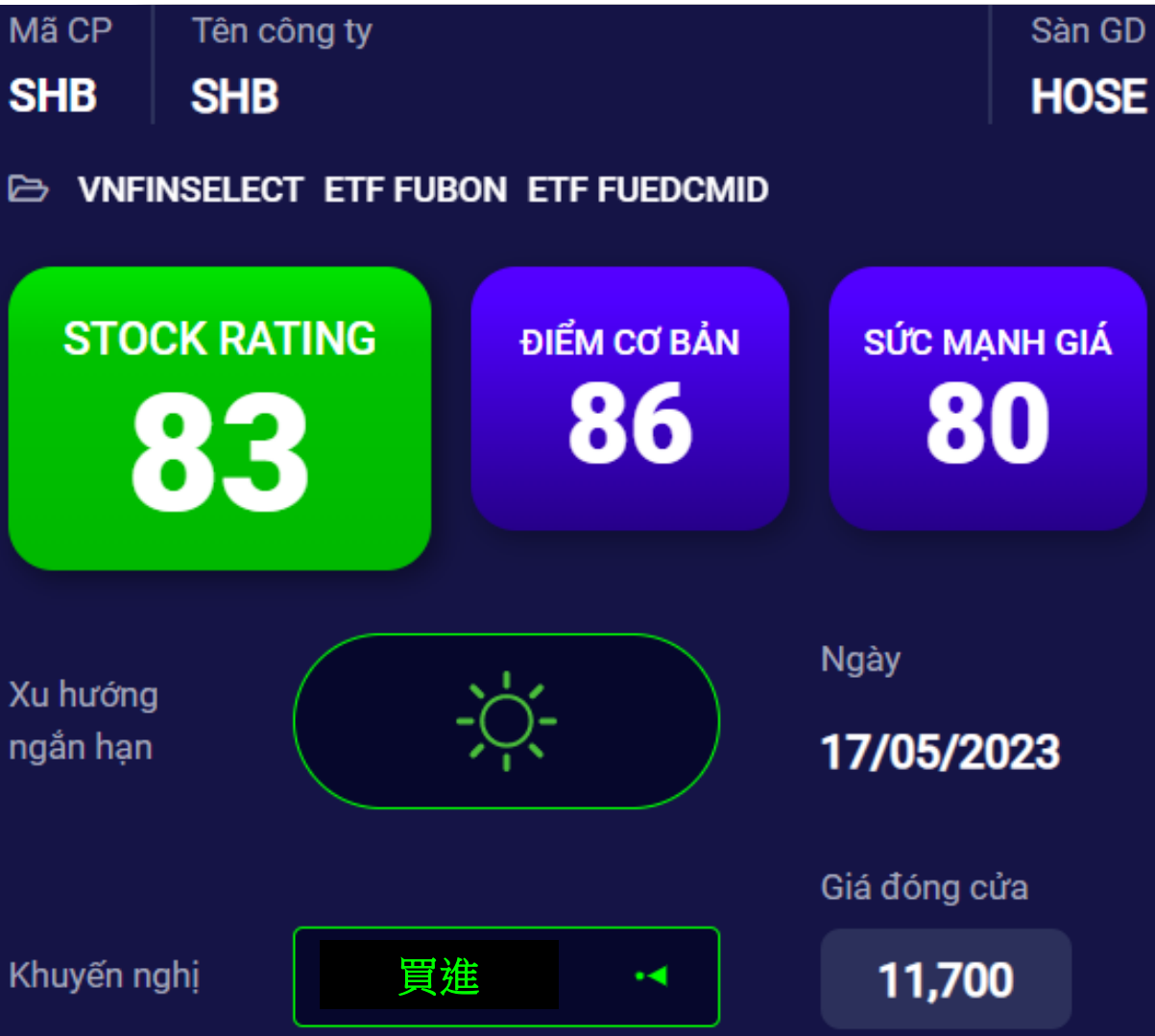

SHB — 進入中期上漲第 3 波階段

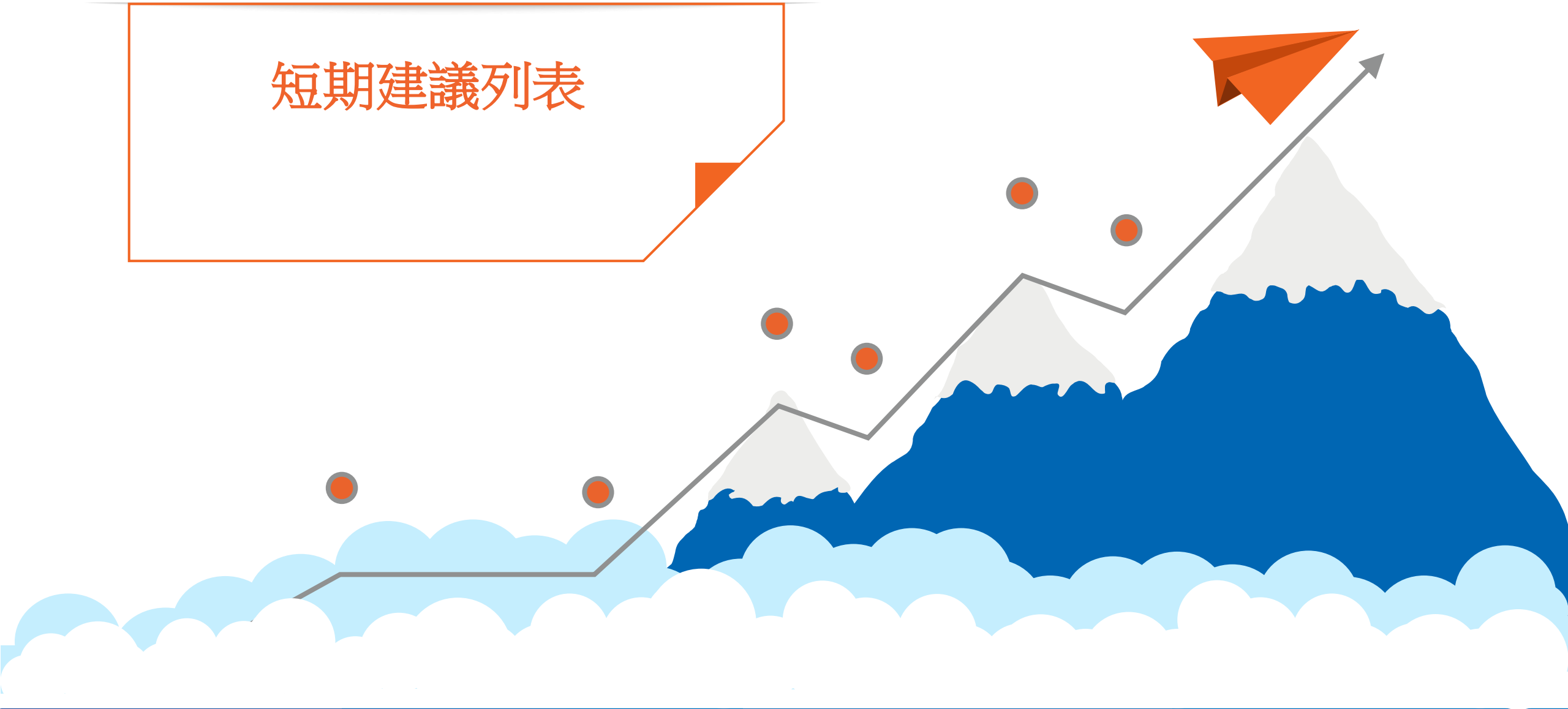
- SHB 的股票評級為 83 點，因此我們將該股評級為積極。
- SHB 的價格走勢圖收漲 0.9%，成交量強勁增加，並突破 20 日均線。同時，SHB 的價格走勢圖仍處於短期調整階段，因此價格走勢圖可能在 11.40-11.70 點的區間內橫盤整理。積極點是，短期現金流出現較為積極的改善跡象。此外，根據價格模式，我們預計 SHB 的價格走勢圖處於中期上漲第 3 波動的階段，預期目標為 14.30。
- SHB 的短期趨勢也調整至上漲。因此，我們建議短期投資者可以考慮以現價買進。
