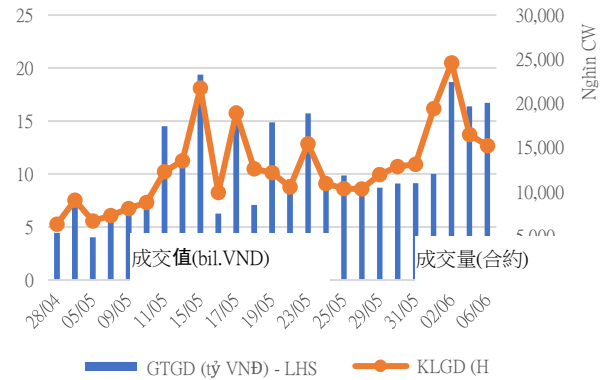


HPG 權證是重點

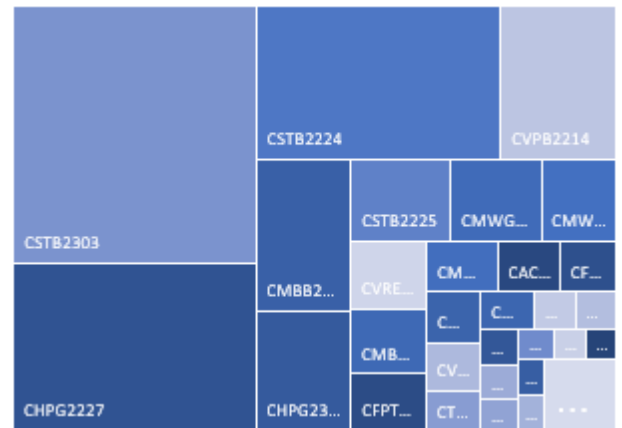

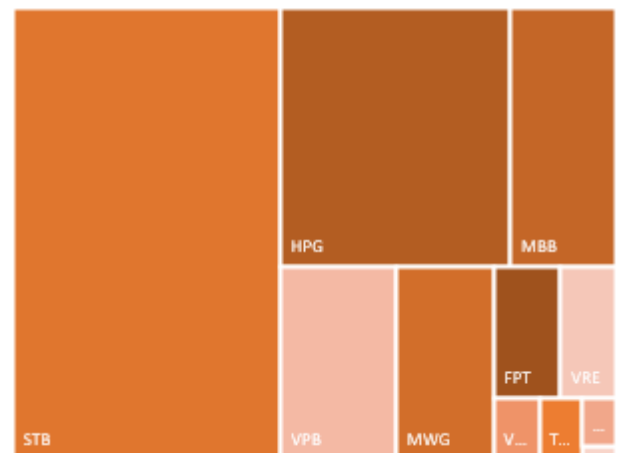
成交值和成交量

槓桿 (Effective gearing) 越高, 按標的證券的波動率就越大。

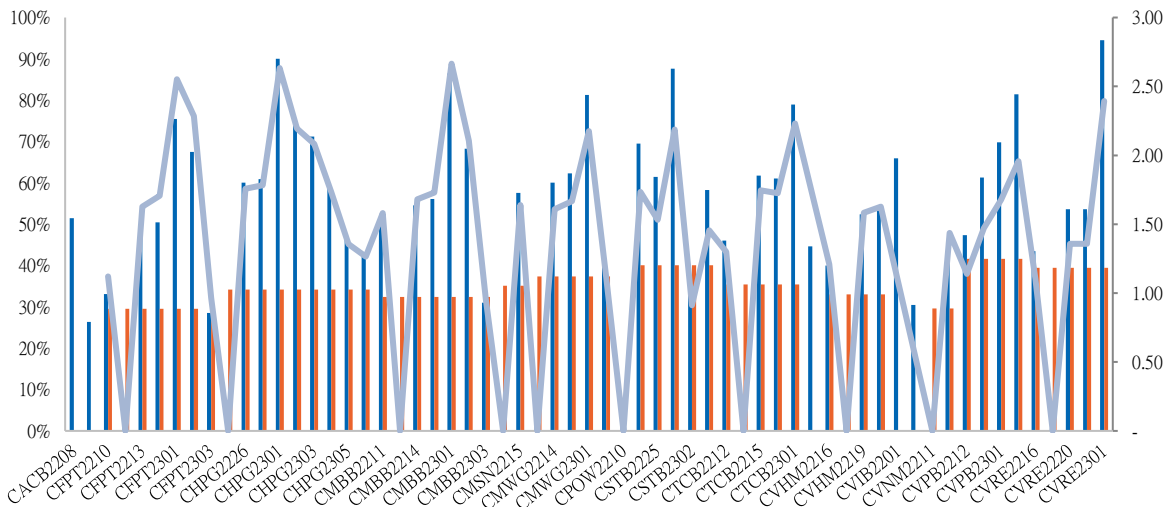
