**合約走勢**

- 期貨合約持續下跌，當時 11 月期貨合約下跌至 1105 點附近的最低水平，並在 ATC 交易日中小幅復甦。VN30F1M 基差再次收窄至 -0.5 點。
- VN30F2311 的成交量增加 3%，VN30F2312 減少 25%，VN30F2403 減少 5%，VN30F2406 減少 33%。

**VN30F1M 的評估**

- VN30F2311 繼續從 1038 點調整，MACD 指標保持強勁的拋售信號。這顯示短期下跌趨勢可能仍尚未結束。同時，跌幅在本周的首個交易日可能不大，市場可能在 1103-1104 點放緩跌勢，並可能會再次逐漸強勁復甦。同時，價格可能在 1110-1111 點最近的阻力位。
- 短期趨勢在 VN30F2311 合約上在日線圖上仍然上漲，追蹤停損於 1082 點。

**投資策略**

<b>當天策略</b> (Intraday)	投資者考慮在 1103-1104 點開設多頭，停損於 1100 點以下，止盈在 1111 點和 1118 點以上。
<b>主要短期趨勢策略</b> (Daily)	投資者保持觀察倉位，並等待新的入場點。



### VN30F1M 合約走勢圖

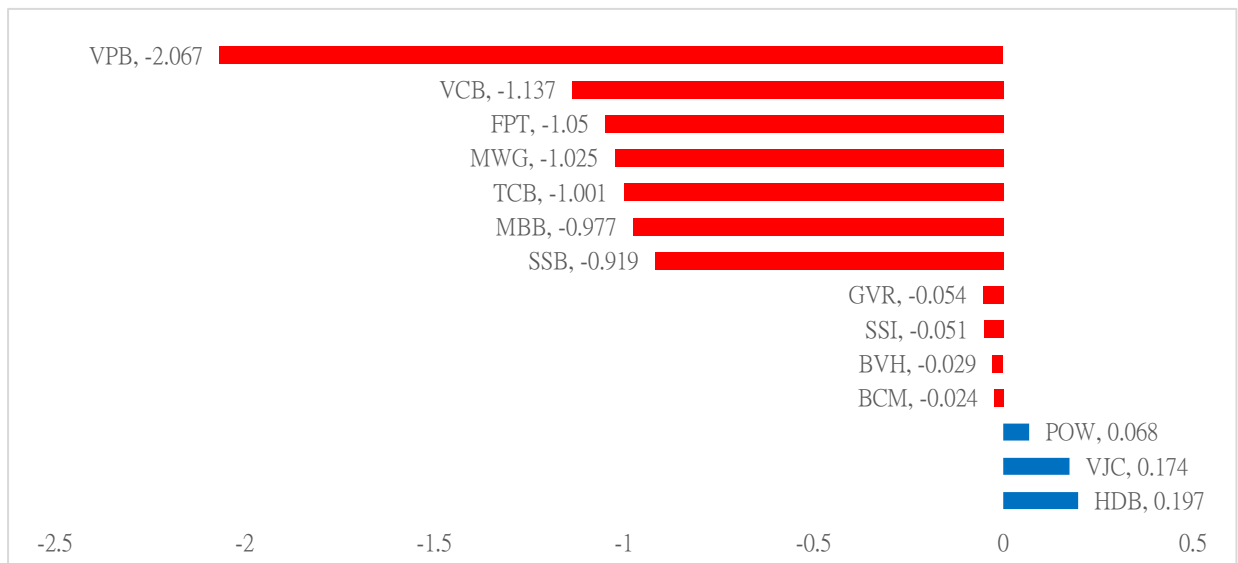

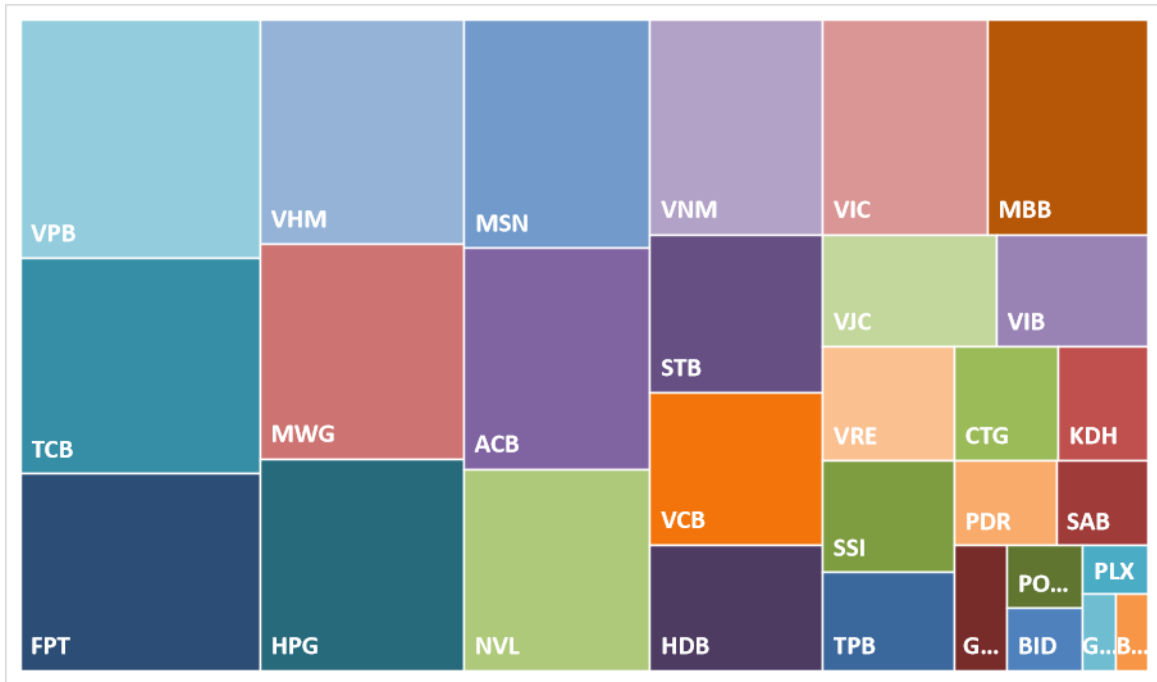
