合約走勢

- 當股票市場在尾盤調整時，期貨市場再次處於強勁震盪的階段。收盤時，VN30F2401 小幅下跌，基差收窄 1.9 點。
- 與前一交易日相比，VN30F2401 的成交量增加 3%，VN30F2402 增加 46%，VN30F2403 減少 83%，VN30F2406 減少 80%。

VN30F1M 的評估

- VN30F2401 處於強勁震盪的階段，並繼續在 1140-1142 點的阻力位。同時，MACD 指標仍發出拋售的信號，因此該合約可能仍會處於震盪的階段，但可能在 1129-1130 點的支撐位。若維持在該區域以上，價格可能再次測試 1140 點的阻力位。
- VN30F2401 合約的短期趨勢在日線圖上維持上漲，價格可能在 1140-1145 點附近的阻力位，而可能在 1117 點的短期支撐位。

投資策略

當天策略 (Intraday)	投資者在早盤考慮在 1130 點開設多頭，停損於 1129 點，目標為 1138-1140 點。 當價格突破 1129 點時考慮開設空頭，停損於 1131 點，目標為 1120 點附近。
主要短期趨勢策略 (Daily)	投資者保持觀察倉位，並等待新的入場點。

VN30F1M 合約走勢圖

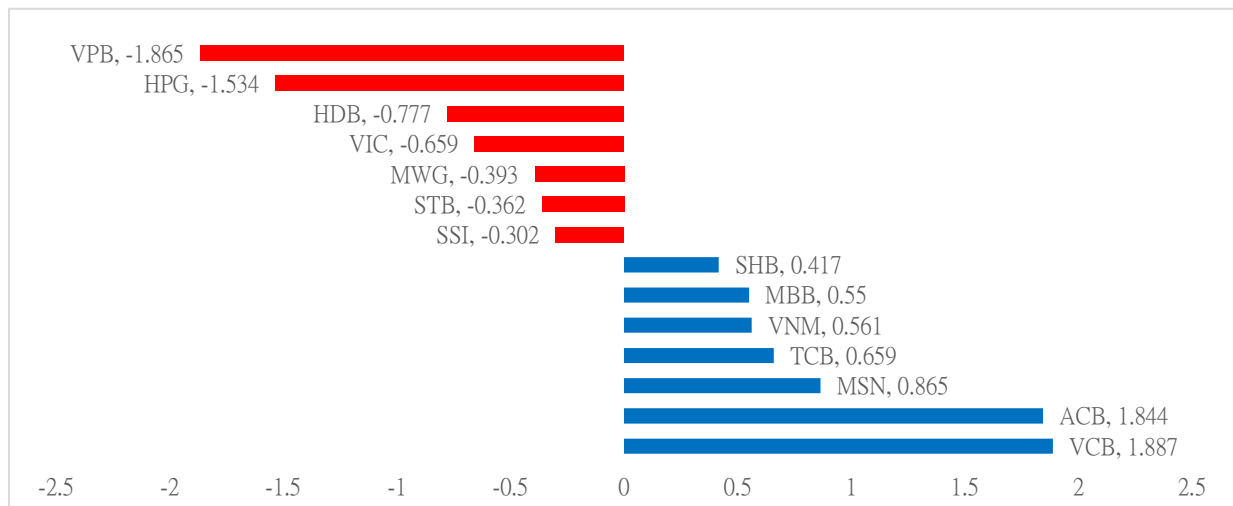

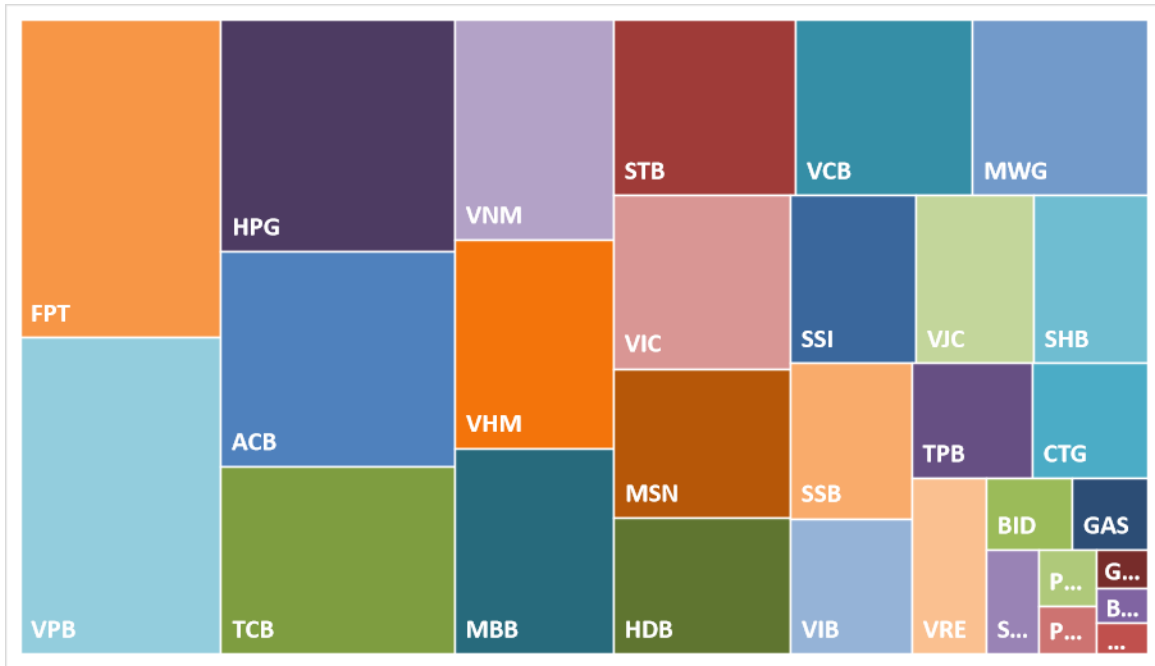
VN30-INDEX 指數走勢
