### 合約走勢

- 美國股市在前一交易日處於負面走勢後，4 個期貨合約下跌，則在開盤時就下跌。但 VN30F2404 逐漸復甦，並收於 1263 點，比參考水平上漲近 3 點。合約的基差達 0.1 點。
- VN30F2404 的成交量超過 19.3 萬份合約，比前一交易日微有減少。

### VN30F1M 的評估

- VN30F2404 繼續橫盤整理，同時保持在 1248-1250 點的舊底部以上。MACD 指標在 1H 幀內仍出現上漲的信號，顯示仍可能會出現短期復甦情境。具體而言，市場在下一個交易日可能上漲至 1267-1270 點。然而，1272-1278 點較高的阻力位可能會再次引發下跌。
- VN30F2404 合約的短期趨勢在日線圖上維持下跌，並可能在 1272-1280 點最近的阻力位。

### VN30F1M 合約走勢圖

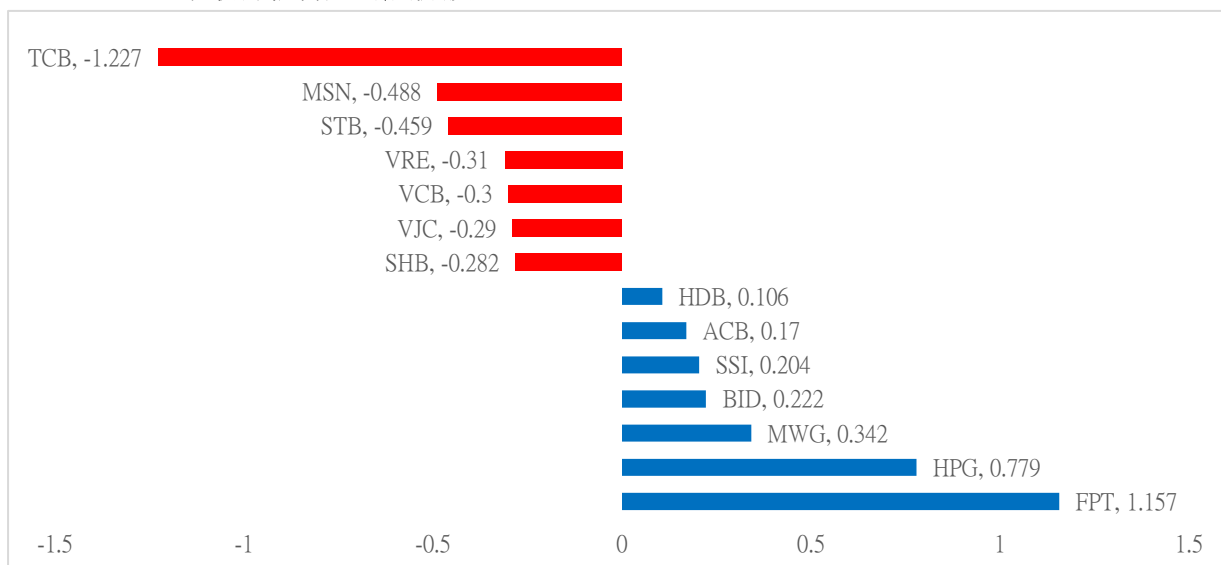

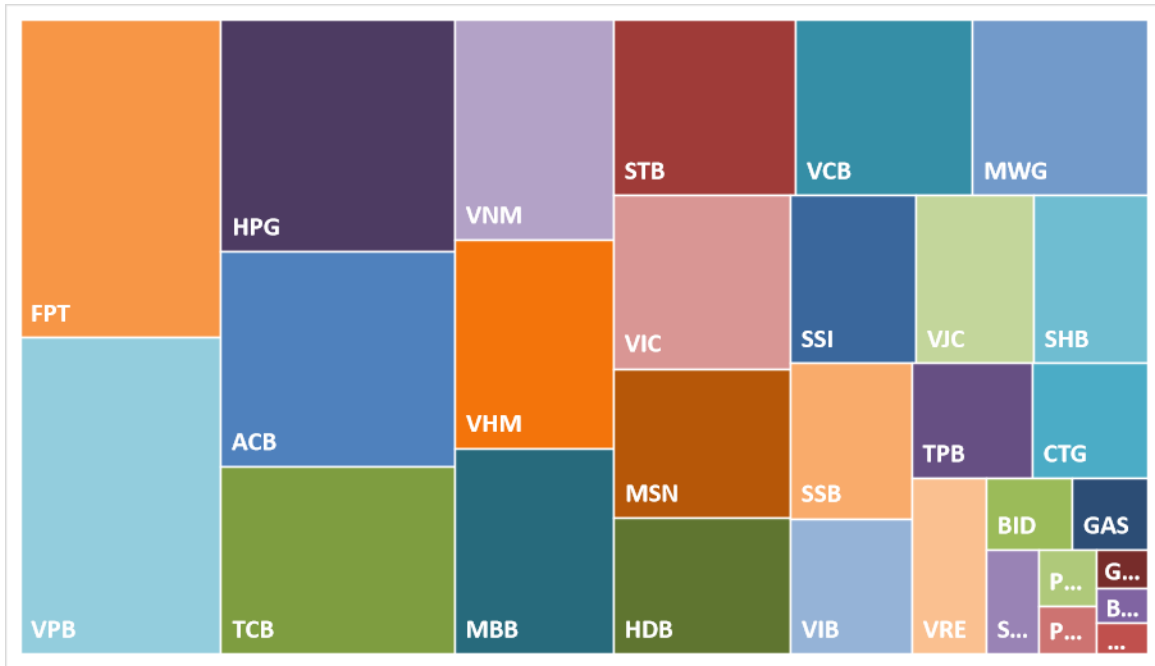
### VN30-INDEX 指數走勢
