- VN30F2409的成交量比前一交易日減少13%,合約的持 倉量在到期周減少至44,600份。

VN30F1M 的評估

- VN30F2409 跌破 1290-1292 點,1H 傾內趨勢轉為下跌趨勢。相當於斐波那契回檔位 50%-61.8%的 1275-1279 點可能會是 9 月合約的調整區域。 MACD 指標在多個時間範圍內出現賣出訊號,訊號線出現背離,顯示漲跌交替期在未來的幾個交易日可能形成。
- 同時, VN30F2409 合約的短期趨勢在日線圖維持下 跌, 追蹤停損相當於 1316 點。




